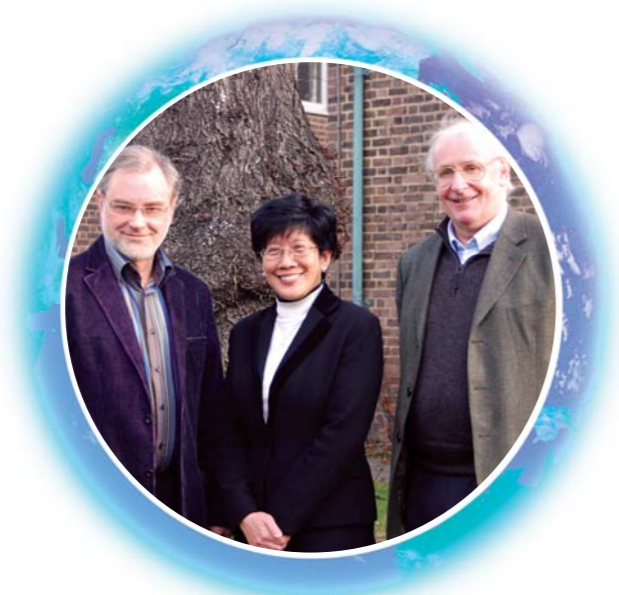


Global co-operation

2010 Joint World Conference on Social Work and Social Development: The Agenda

The Conference offers a unique platform for more than 2,000 professionals, academics, practitioners, social planners, policy makers and advocates from East and West to meet, exchange, and develop an action agenda for social work and social development in the next decade.

We invite you to be part of the process of envisioning and shaping the agenda, to set the questions, to start the debates, and to:

- Share new knowledge and skills, document best practice and development strategies, promote evidence-based practice and empower each other in the pursuit of quality, excellence and innovation in practice and advocacy of social development and social work;
- Create learning opportunities as well as forums to expand the dialogue to find new solutions or new roles for the profession to meet the changing needs and problems;
- Lead the global debate, engage global institutions and create synergies among professionals to lead the global agenda for people-centered sustainable social progress.



Conference Themes

Discussions on Practice, Policy and Education cut across the following 3 themes and 25 sub-themes in formulating "The Agenda". The emphasis is on the systematic application and generation of knowledge and intervention to result in evidence-based outcome in social work and social development.

I. Life Course Challenges & Actualization

Social Work is becoming more complex and varied in different cultures. We see the impact of the macro environment and new technology, which may be disabling and disempowering to our client groups that range from the child to youth, to adulthood and then old age. Meanwhile, gender issue, the challenges to the marriage and family system as well as the threats to physical, psychologically and social well-being of the individual at different life stages are highly topical issues that need to be addressed at the policy, practice and education parameters. There are micro and macro evidence-based interventions that practitioners and advocates have developed and can be shared, with the aim of promoting the actualization of the individuals' potentials as well as impacting on overall social development.

II. Equity & Social Inclusion

There is a general awareness of the challenges that we have to cope in a world with diversity. In order to cope with poverty, unemployment and discrimination, equity and social inclusion principles have been adopted in policy making mechanisms. But how effective are these initiatives? How we eradicate poverty, deprivations and vulnerability; and enhance social development? Have we eliminated discrimination on the ground of disability, gender, race, religion by means of anti-oppressive practices? Have we improved the quality of life of those who are labeled as deviant, vulnerable or at risk? Are we advocates or just managers? Could we really balance economic with social development in the long term and for whom we should fight?

III. Sustainable Environment

Creating a sustainable environment has become one of the major challenges for researchers, scholars and practitioners across many disciplines. This theme explores the interplay of multiple, complex forces that bring rapid transformation in and far-reaching impacts on our natural, social and economic environment. As well, it discusses locally and globally integrated policy solutions and current innovative professional practices in environments, health, population movements, disaster management, housing, rural-urban resettlement, community development and preservation, corporate social responsibility, civil society, self-help movements, and planning of welfare. The discussion would contribute to the creation, accountability, resourcing management, protection, restoration, enhancement and conservation of a sustainable environment to uphold social justice, harmony and well being.

You are invited to submit abstracts on topics related to the Conference theme and sub-themes for presentation in the Conference. Other than oral and poster / video presentations, other formats could also be accepted – please specify on the abstract.

General Information

1. Abstracts should be original in nature and have not been previously published in any form, such as journal article or conference presentation.
2. Submission of more than one abstract from a single participant is permissible.
3. All Conference presenters must register for the Conference and pay the registration fee for their presentation to be included into the final programme.
4. All participants who have submitted abstracts are eligible to apply for Scholarships for Participants from Developing Countries and Best Abstract Awards.

Abstract Review, Selection and Publication

1. All abstracts will be peer-reviewed by the Sub-theme Coordinators. A paper may be accepted for oral presentation or poster session.
2. Abstracts submitted before the deadline and accepted for presentation will be published in the proceedings of the Conference.
3. Once an abstract is accepted by the Organizing Committee and presentation confirmed by the author(s), the copyright of the abstract and paper will be shared by the 2010 Joint World Conference on Social Work and Social Development: The Agenda.
4. Only fully registered authors will be allowed to make presentation in the Conference.

Notification of Results

Notification of acceptance (or rejection) of your abstract will be sent to the email address indicated on the abstract form before 15 January 2010.

Best Abstract Awards

A total of 150 Best Abstract Awards will be given for 3 categories of participants:

- Best Abstract Award (Student)**
- Best Abstract Award (Practitioner)**
- Best Abstract Award (Researcher)**

For each of the 25 sub-themes, two best abstracts with outstanding academic and professional merits will be awarded for each category of participants, and the main author will be waived half of the registration fee.

Presentation & Publication

While the awards will be presented during the Conference, winners will be selected prior to it by a selection committee. The winning abstracts / papers may be selected for inclusion in a special Conference Publication. The authors of the winning papers will be requested to make presentation in the Conference.

Award Criteria

- a) Relevance: topic is relevant to the theme / sub-themes of the Conference
- b) Knowledge Contribution: Abstract builds and expands on the previous work/literature/theories
- c) Innovativeness: The material shared is up-to-date, innovative, and will lead to future advancement in social work and social development
- d) Clarity: Abstract is clearly presented and includes all essential information
- e) The selection committee reserves the rights to select less than 2 best abstracts for certain categories of the sub-themes. The decision of the selection committee is final.

Scholarship for Participants from Developing Countries

One of the major objectives of this Conference is to promote international exchange among participants from different cultures. The captioned scholarship scheme is therefore set up to finance potential participants from developing countries who can contribute to the conference but are in need of financial support in order to make those contributions.

**Deadline for Application:

Eligibility Criteria of Applicant

The applicant must:

- be citizens of developing countries and at the time of application be living and working in those countries;
- have demonstrated ability to contribute to the Conference, with priorities given to applicants who have submitted an abstract or proposal of presentation;
- not be receiving other awards or scholarships from the Conference Organizers.

Responsibilities of Selected Applicants

The selected applicants must:

- participate in the event fully;
- be responsible for traveling, accommodation and all other expenses which are not covered by the scholarship awarded by the Conference Organizers.

Selection

An independent selection panel will be formed to award scholarships of varying amount to different qualified applicants who can demonstrate their ability to contribute to the Conference. Applicants should expect that the scholarship will only cover some of the expenses and fees and should note that grants will be released by reimbursement. The screening process will start in **December 2009**. The selection panel will exercise discretionary power to award scholarships to some special cases who cannot meet the eligibility criteria.

All applicants will be informed about the final decision before the end of January 2010.
